SCOPE OF THE WORK

The tender is for the supply, installation, testing & commissioning of Biometric Attendance System. This Biometric Attendance System is for the use of Vidhan Sabha Secretariat. Total 03 numbers Biometric Attendance Machines are required.

Chhattisgarh Vidhan Sabha Secretariat intended to select single or different models of any particular or different make with rates by this tender process. Vidhan Sabha Secretariat can choose and take any of the approved models. After testing verification and entries, the bills of the Biomatric Attendance System will be paid by the Vidhan Sabha Secretariat. As per the Terms and Conditions the firm will provide the after sales services and the warranty facilities accordingly. The Scope of work includes supply, installation, testing & commissioning under warranty obligation.

Important Note

- (1) All corrigenda, addenda, amendments and clarifications to Tender Specifications will be hosted in the website. www.cgvidhansabha.gov.in and not in the newspaper, Bidders shall keep themselves up dated with all such developments.
- (2) In case the last date of receipt/opening of bids falls on holiday, the bids shall be receipt/opened on the following working day at the same time and venue.
- (3) Tenderer who have downloaded the tender document form from the vidhan sabha's website shall submit a declaration alongwith tender document that I/We have downloaded the Tender Form from the Vidhan Sabha website www.cgvidhansabha.gov.in and I/we have not Tempered/Modified the tender form in any manner. In case, if the same is found to be tempered/modified in any manner, I/We understand that my/our tender will be summarily rejected and I/We are liable to be banned from doing business with the Vidhan Sabha Secretariat.
- (4) While Submitting the tender, tenderers must submit Tender fee, EMD, Technical Bid and financial Bid in four different envelopes clearly marking the contents as detailed below on the body cover of each envelope in bold letters:

The tender not submitted in accordance with the above mentioned criteria is liable to be rejected further, envelope 'D' i.e; Financial Bid will be opened only of those bidders whose bids are found according to eligibility criteria.

- (5) Supplier must mention Full address with Phone No. and email-ID on their envelopes also.
- (6) Tender document fee of Rs 500/- (Non refundable) with EMD amounting to Rs. 10,000/- both in form of DD favouring Principal Secretary, Chhattisgarh Vidhan Sabha are to be submitted with tender document failing which offer will not be considered.

The quoted bid must be quoted duly typed on the letter heads of the supplier/ manufacturer with mentioning of full address, VAT No./PAN No./TDS NO./ TIN No./ and must be contained in a sealed envelope which should be superscribed as "Bid for supply, installation, testing and commissioning of Biometric Attendance System Short Tender No. 848/Estt./CGVS/2015 dated 06/02/2015 with due date and time on the cover of envelope.
- 4. The last date of submission of tender is 23/02/2015 by 3.00 PM. These bids will be opened on the same day at 4.00 PM in the Committee room No. 3 of Chhattisgarh Vidhan sabha in the presence of the tenderes (s) or their authorised representative (s) who wish to remain present at the scheduled time.
- 5. Telefax / E-mail and other incomplete offer will not be considered.
- All Bids will be deemed to be FOR Chhattisgarh vidhan sabha unless otherwise specified and should include packing and forwarding charges.
- 7. If quoted otherwise than FOR Chhattisgarh vidhan sabha insurance, Charges from place of loading to destination shall be borne by the supplier.
- 8. All Bids will be valid for at least 60 days excluding the date of opening.
- 9. Illustrated literature and catalogue must be furnished along with Bid.
- 10. The supplier must intimate whether he is manufacturer, dealer or supplier. In case of supplier or dealer the authorization from the manufacturer is required and copy of the same must be enclosed with the bid.

- 11. Rates should be quoted in the Indian rupees only.
- 12. The Chhattisgarh vidhan sabha is not liable to pay interest on EMD. Earnest money deposit shall be forfeited, it the tenderer, withdraws its bid during the period validity. The Earnest money deposit of the tenderer, whose tender has been accepted, will be returned on the submission of performance security @5% of the total value of the offer. The performance security will be kept till the warranty period ot the Biometric Attendance System. The warranty period will start from the date of satisfactory installation, testing and commissiong of the Biometric Attendance System duly given by the concerned department. Earnest money deposit of the successful tenderer shall by forfeited, if it refuses or neglects to execute the contract or fails to furnish the required performance security within the stipulated time frame as specified by the Chhattisgarh vidhan sabha. The EMD (s) of other Bidder (s) whom offer will not found according to required specification/ lowest will be released after finalization of the purchase.
- 13. The Bid may by rejected by the Principal secretary, Chhattisgarh vidhan sabha without assigning any reason.
- 14. The Bid received after the due date will not be considered unless the date is extended.
- 15. In case the last date of receipt of Bid falls on holiday, the Bid shall be opened on the following working day.
- 16. The make/ model of Biometric Attendance System and country of origin must be clearly specified. Warranty of the Biometric Attendance System may be intimated. The after sales service policy also be clarified and address of the Sales Service Centre be intimated.
- 17. Two years of working spares wherever required should by quoted on FOR destination basis. The Principal Secretary Chhattisgarh Vidhan Sabha reserves the right to order any or all the spares as quoted by the tenderers and on the terms and conditions quoted for the Biometric Attendance System. The responsibility of the tenderer under the warranty clause will not be diluted in any way on this account.
- 18. Specitications can be changed depending upon suitability only after delibration/ discussion. Nearest specification/ better specification can be considered. In case of deviation complete justification should be furnished with proper documents.
- 19. Freight paid sample must reach this office before or at the latest by the due time and date of the opening of the Bids, if required.

- 20. It may be stated clearly, whether the items quoted are available in stock. If not the minimum period of supply of goods be indicated.
- 21. Rate quoted should be excluding taxes. Percentage of taxes of be charged must be clearly stated.
- 22. The approved samples will be sealed, duly signed by the representative of the quotee and kept in the office at the time of release of the order (where applicable.)
- 23. Inspection of Biometric Attendance System / or parts of Biometric Attendance System will be carried out by the consignee or the Inspection Committee at the destination and if rejected Biometric Attendance System or parts of Biometric Attendance System will have to be removed within 10 days from the date of dispatch of advice from the indenting officer, failing which the quote shall be responsible for the loss.
- 24. The rejected Biometric Attendance System of parts of Biometric Attendance System must be replaced within 15 days of the dispatch of advice by the indenting officer or a registered notice, failing which indenting officer will be entitled to make arrangements of its disposal without any further reference.
- 25. Certificate to the effect that the Price quoted by you will be lowest and is not more than the Price charged from other government departments in India.
- 26. Copies of supply order at least of three users where you have already supplied above said Biometric Attendance System be supplied.
- 27. Details of training by the institute be intimated.
- 28. The 90% payment will be released against physical delivery and inspection of the equipment and balance 10% payment shall be released within 15 days after having the inspection and installation report of the equipment/material, execution of the complete order of goods as per specification of the supply order and their installation and working.
- 29. The quantity of Biometric Attendance System may vary as per requirment.
- 30. The tenderer should not have been debarred and/ or blacklisted by any Central Government/ or any State Government Department (s)
- 31. Penalty. The Principal Secretary, Chhattisgarh Vidhan Sabha shall have the power to impose penalty upto 5% of the value of the order if the supply is not executed within the stipulated/ extended period.
- 32. The tender document duly signed and stamped on each pages shall be returned in original with the Technical bid as a proof, to confirm the acceptance of the entire terms and conditions of tender.
